Re: Automatic Exchange of Information for Tax Purposes ("AEOI") Common Reporting Standards ("CRS") Revised List of Reportable Jurisdictions

Reference is made to the Central Bank of Bahrain's ("CBB") Directive OG/273/2018 dated 20th June 2018, regarding Automatic Exchange of Information for Tax Purposes ("AEOI") Common Reporting Standards ("CRS") Reporting Deadline.

The CBB would like to inform you that the Kingdom of Bahrain's list of CRS reportable jurisdictions for the year ending 31st December 2017 has been updated to include additional nine new jurisdictions as per the Table attached.

Therefore, the CBB requests all Reporting Financial Institutions ("RFI"s) to revise their final CRS reports by 19th August 2018 through the new AEOI Portal. The following link provides access to the above-mentioned portal:

The final CRS report must be in line with the CRS and its Commentaries requirements stipulated in the Standard for Automatic Exchange of Financial Account Information in Tax Matters (the "Standards"). The Standards are available in the following website:
